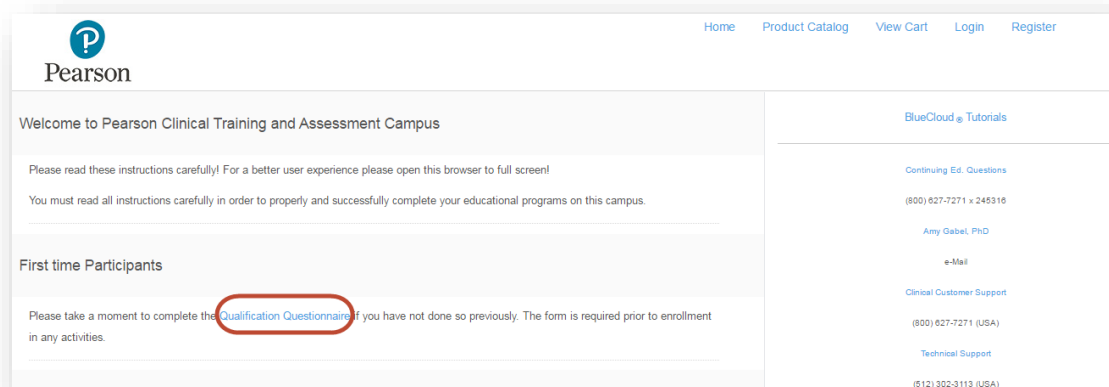




## Training Campus – Qualification Questionnaire

1. If you have not already done so, the first step is to create an account (register) in the system. To complete this process, go to [Pearson Clinical Assessment Training Campus](#). You will create your unique username and password as part of this free registration process.
2. Before taking online courses or professional development tests, all users are required to complete the Qualification Questionnaire. To complete the form, click on the Qualification Questionnaire link on the home page. The Qualification Questionnaire is composed of questions pertaining to: Licensure/Certification, Education, and Organization Membership(s). You must respond to all questions, even if it's an N/A.



After you have selected/entered the requested information, click on the arrow to proceed to the next item.






