- 2. Formulate how students' results can be used in the selection and application of BASC–3 interventions and supports.

# BASC-3 Promoting Social, Emotional, and Behavioral Well-Being Development Course Description:

This learning track addresses how a well-being focus using the BASC–3 can be applied in our schools to promote student social/emotional development and address behavioral and mental health issues. This session focuses on a strengths-based approach to screening, assessment, and intervention planning in order to identify behavioral components of student well-being and to support their development.
