Yossef Ben-Porath is professor of psychological sciences at Kent State University. He received his doctoral training at the University of Minnesota and has been involved extensively in MMPI research for nearly 40 years. He is codeveloper of the MMPI-3, MMPI-2-RF, and MMPI-A-RF and coauthor of test manuals, books, book chapters, and articles on the MMPI instruments. Former editor-in-chief of the journals *Assessment* and *Psychological Assessment*, Dr. Ben-Porath is a board-certified clinical psychologist (American Board of Professional Psychology-Clinical) whose clinical practice involves supervision of assessments at Kent State's Psychological Clinic, consultation to agencies that screen candidates for public safety positions, and provision of consultation and expert witness services in forensic cases.
