# Overview

Clinical Evaluation Language Fundamentals Preschool, Third Edition is a language assessment used by Speech Language Pathologists to determine if children ages 3-6 have acquired the language skills, they need to master the language demands of the classroom. # Who is eligible to earn ASHA CEUs?

Effective July 1, 2011, individuals must meet at least one of the following conditions in order to be eligible to earn ASHA CEUs.

- ASHA Member (includes Life member and International affiliates)
- ASHA Certificate of Clinical Competence (CCC) Holder
- Licensed by a state or provincial regulatory agency to practice speech-language pathology (SLP) or audiology
- Credentialed by a state regulatory agency to practice SLP or audiology
- Credentialed by a national regulatory agency to practice SLP or audiology
- Engaged in a Clinical Fellowship, which is supervised by someone with their ASHA CCC
- Currently enrolled in a masters or doctoral program in SLP or audiology

# What does the ASHA CE Registry do to determine eligibility?

If we receive an ASHA CEU Participant form for an attendee who is not in our database as an "eligible" Registry user, we will ask them to provide documentation of eligibility prior to awarding ASHA CEUs.
